- 3. Feasibility Study We are now partnered with the SIUE School of Business to have a feasibility study conducted by their two MKTG 377 Marketing Research classes. We had a conference call with Professor Mike Hair earlier this month and have a timeline for our study as their class project this semester. We will be presenting to the two classes in early September to go over what we are looking for in this project.
- 4. WCP Dog Bowls no additional businesses added since our last meeting.
- 5. T-Shirt Awareness Campaign Amy needs to lock down a couple more business to sell these so we can determine how many to order and when.

- 6. Yard Sign Awareness Campaign Local quotes so far are pretty high. Amy will get a quote from a wholesale contact she has. These could also be good for putting in business windows or we could consider selling them.
- 7. City Council Meetings nothing of note at the last city council meeting. At the July park board meeting, there was a discussion on applying for the Oslad Grant that was re-instated this year, possibly with the intention of building a splash pad. The maximum grant amount is \$ 400,000 if a land acquistion is not required. The deadline for applying is August 19<sup>th</sup>. They adjourned undecided on the matter.

- Kim provided an example from Decatur IL for the Build Illinois Bond Fund. They were in the process of building an aquatic center. The community wanted to have a lazy river and splash pad for the project, but that was not in their project budget. Their state representative worked with the local park district to get them \$ 3 million to add that to the project. Each state representative can apply for money from the Build Illinois Bond Fund to be used for targeting economic growth.
