## **Meeting Minutes**

## **Officer/Committee Reports**

- 1. Amy Grandcolas called the meeting to order. Scott made a motion to approve the January meeting minutes, Mary seconded the motion. The motion was carried without objection.
- 2. President Amy Grandcolas Provided an update on the Pap Vito's outreach and fundraising night. The new date will be February 22, due to scheduling concerns with Papa Vitos.
- 3. Vice President Dawn indicated she had no report to make.
- 4. Treasurer Celeste was unavoidably detained, and the Treasurer's report was unavailable at meeting time.
- 5. Secretary The secretary had nothing to report.
- 6. Committees
  - a. The Outreach and Fundraising Committee announced that the Papa Vito's outreach and fundraising event is rescheduled for Tuesday, February 22. Dawn is again coordinating volunteer shifts. Papa Vito's will provide all labor for cooking and running phones. Volunteers will be delivering pizzas. There will be flyers provided to go out with deliveries with a call to action for donations. There will be a QR code for donations. Board Members are encouraged to send out Facebook invites. Celeste updated the Board that the St. Patrick's Day 5K is scheduled for March 19, and "ready to go" in that all necessary permits have been obtained. Sponsorships are already coming int and the Facebook event is ready to be marketed. Celeste requested input around the shirt designs and there was general approval of the designs.
  - b. The Capital Campaign Committee announced that a donation was made to the capital campaign in the name of Carl Vogt, who recently passed, on January 18. The board expressed its appreciation to the family.

- 2. Lea Reported that it is early in the year, and there haven't been any new and relevant grant opportunities, but she is keeping an eye out for anything that may be announced.

#### **New Business**

- Amy next led a discussion with the Board concerning a meeting that she and Eric took with a representative from Stifel Nicolaus' investment banking team and presented to the Board a copy of the bond financing analysis that has since been provided. Of particular interest coming out of the meeting was that industrywide, investment banking firms do not typically charge fees for putting together proposals and analyses, and that they are compensated through commissions charged with the bonds are sold to investors.
  - a. Amy indicated that packet is being prepared with the relevant information, to be presented to the Park district. Printed drafts shown to the board are not final and not approved for public distribution.
  - b. Amy also discussed with the Board strategies for communicating this information to both the Park District and to the Waterloo City Council.
- 2. In alignment with the bond proposal information, Amy led the Board in a discussion aroud strategies to communicate to the Park District the level of Community Support at their March Meeting and encouraged all Board Members to talk-up the meeting and request the public to attend and show support.
